## II. DETAILED INFORMATION ABOUT THE FUNDING OPPORTUNITY

### II.A. Program Description

Applications to the Fiscal Year 2019 (FY19) Ovarian Cancer Research Program (OCRP) are being solicited for the Defense Health Agency (DHA) J9, Research and Development Directorate, by the U.S. Army Medical Research Acquisition Activity (USAMRAA) using delegated authority provided by United States Code, Title 10, Section 2358 (10 USC 2358). As directed by the Office of the Assistant Secretary of Defense for Health Affairs (OASD[HA]), the DHA manages the Defense Health Program (DHP) Research, Development, Test, and Evaluation (RDT&E) appropriation. The execution management agent for this Program Announcement is the Congressionally Directed Medical Research Programs (CDMRP). The OCRP was initiated in FY97 to provide support for research of exceptional scientific merit. Appropriations for the OCRP from FY97 through FY18 totaled \$316.45 million (M). The FY19 appropriation is \$20M.

The mission of the OCRP is to support patient-centered research to prevent, detect, treat, and cure ovarian cancer to enhance the health and well-being of Service members, Veterans, retirees, their family members, and all women impacted by this disease.

### II.B. Award Information

The OCRP Ovarian Cancer Academy Award mechanism, which was initially created in FY09, is a unique, interactive virtual academy providing intensive mentoring, national networking, collaborations, and a peer group for junior faculty. The overarching goal of the Ovarian Cancer Academy (OCA) is to develop successful, highly productive ovarian cancer researchers in a collaborative research and career development environment.

The OCA is a virtual career development and research training platform that currently consists of 13 Early-Career Investigator (ECI)/Designated Mentor pairs from different institutions, and one Academy Dean and one Assistant Dean. Three ECIs will be graduating in the fall of FY19 and three FY18 OCA-ECI/Designated Mentor awards will be made by September 2019. In addition, eight have Academy graduates continue to participate in the annual Academy meetings. Information about the Academy is available in the FY17 Ovarian Cancer Program Booklet at <http://cdmrp.army.mil/ocrp/pbks/ocrppbk2017.pdf>. The Academy Dean and Assistant Dean catalyze the growth and professional development of the ECIs in collaboration with their Designated Mentors, assess the progress of the ECIs, and facilitate communication and collaboration among all of the Academy members.

This FY19 Funding Opportunity is soliciting applications for an Academy Dean and Assistant Dean to lead the OCA for an anticipated start date in first quarter of FY20 – exact date to be determined. The Academy Dean and Assistant Dean (referred to as Academy Leadership) must be established ovarian cancer researchers, and can be at different institutions. Designated Mentors on FY19 Ovarian Cancer Academy – Early-Career Investigator Award applications and current Designated Mentors of Ovarian Cancer Academy – Early-Career Investigators (with the exception of those graduating in 2019) are *not* eligible to apply for this award. The Academy

Leadership must demonstrate a strong record of mentoring and training junior investigators, a commitment to leadership, and the ability to objectively assess the progress of all of the ECIs in the OCA.

Responsibilities of the Academy Leadership include, but are not limited to:

- Act as a resource for all ECIs and Designated Mentors in the Academy over the 5-year period of performance as Academy Leadership.
- Facilitate communication and collaboration among all of the ECIs and Designated Mentors (including periodic interactive communication among all Academy members).
- Develop assessment criteria to evaluate the research progress made by all of the ECIs, as well as their career progression and sustainment as independent investigators in ovarian cancer research.
- Conduct collaborative ovarian cancer pilot project(s) that include Academy ECIs. These pilot projects should have the potential to improve collaboration within the Academy, as well as impact ovarian cancer research and/or ovarian cancer patients/survivors.
- Provide constructive critiques with the goal of advancing the research and professional careers of the ECIs and strengthening the mentorship of the Designated Mentors.
- Provide avenues to increase the visibility of ECIs within the ovarian cancer research and advocacy communities (e.g., peer review, conferences, editorial boards).
- Support the professional development to include lab management skills, of the ECIs into leading researchers through invited presentations by experts outside of the OCA.
- Plan and host an annual 1-day workshop and biennially, a multi-day workshop for all ECI/Designated Mentor pairs as well as Academy graduates to present their research, share knowledge, and develop collaborative efforts within the OCA.
- Invite and financially support the travel for OCA graduates to attend the annual meetings, including them as speakers and participants.
- Assemble an Advisory Board to the Academy to include Academy alumni.

***The Ovarian Cancer Academy Dean and Assistant Dean (Leadership) Award is structured to support two Principal Investigators (PIs).*** The Academy Dean will be identified as the Initiating PI and will be responsible for the majority of the administrative tasks associated with application submission. The Assistant Dean will be identified as the Partnering PI. The collaboration between the Academy Dean and the Assistant Dean should be supported by complementary expertise and experience. Initiating and Partnering PIs each have different submission requirements, as described in [Section II.D.2, Content and Form of the Application Submission](#); however, both PIs should contribute significantly to the development of the proposed research project. The application should clearly demonstrate that both PIs have equal levels of input on the proposed Academy Leadership and clearly define the components to be

addressed by each to continue the success of ECIs. While it is up to the Academy Dean and the Assistant Dean to define their roles, both Academy Leaders should have interactions with the ECIs; acting as administrative support does not fulfill the intent of the Assistant Dean. If recommended for funding, each PI will be named to an individual award within the recipient organization.

The anticipated direct costs budgeted for the entire period of performance for the Initiating PI (Academy Dean) and the Partnering PI (Assistant Dean) awards for the entire 5-year period of performance for the FY19 OCRP Ovarian Cancer Academy Dean and Assistant Dean (Leadership) Award will not exceed \$1.75M. Refer to [Section II.D.5, Funding Restrictions](#), for detailed funding information.

*The CDMRP expects to allot approximately \$2.8M to fund approximately one Ovarian Cancer Academy Dean and Assistant Dean (Leadership) Award application. Funding of applications received is contingent upon the availability of Federal funds for this program as well as the number of applications received, the quality and merit of the applications as evaluated by scientific and programmatic review, and the requirements of the Government. Funds to be obligated on any award resulting from this funding opportunity will be available for use for a limited time period based on the fiscal year of the funds. It is anticipated that awards made from this FY19 funding opportunity will be funded with FY19 and FY23 funds, which will expire for use on September 30, 2025 and September 30, 2029, respectively.*

Awards will be made no later than September 30, 2020. For additional information, refer to [Section II.F.1, Federal Award Notices](#).

The types of awards made under the Program Announcement will be assistance agreements (grants or cooperative agreements). The level of involvement on the part of the DoD during project performance is the key factor in determining whether to award a grant or cooperative agreement.

An assistance agreement (grant or cooperative agreement) is appropriate when the Federal Government transfers a “thing of value” to a “state, local government,” or “other recipient” to carry out a public purpose of support or stimulation authorized by a law of the United States, instead of acquiring property or service for the direct benefit and use of the U.S. Government. If “no substantial involvement” on the part of the funding agency is anticipated, a grant award will be made (31 USC 6304). Conversely, if substantial involvement on the part of the funding agency is anticipated, a cooperative agreement will be made (31 USC 6305) and the award will identify the specific substantial involvement. Substantial involvement may include collaboration, participation, or intervention in the research to be performed under the award. The award type, along with the start date, will be determined during the negotiation process.

**Research Involving Human Anatomical Substances, Human Subjects, or Human Cadavers:** All DoD-funded research involving new and ongoing research with human anatomical substances, human subjects, or human cadavers must be reviewed and approved by the U.S. Army Medical Research and Materiel Command (USAMRMC) Office of Research Protections (ORP), Human Research Protection Office (HRPO), prior to research implementation. This administrative review requirement is in addition to the local Institutional

Review Board (IRB) or Ethics Committee (EC) review. Local IRB/EC approval at the time of submission is *not* required. The HRPO is mandated to comply with specific laws and requirements governing all research involving human anatomical substances, human subjects, or human cadavers that is supported by the DoD. These laws and requirements will necessitate information in addition to that supplied to the IRB/EC. ***Allow a minimum of 2 to 3 months for HRPO regulatory review and approval processes.*** Additional time for regulatory reviews may be needed for clinical studies taking place in international settings. When possible, protocols should be written for research with human subjects and/or human anatomical substances that are specific to the DoD-supported effort outlined in the submitted application as a stand-alone study. Submission to HRPO of protocols involving more than the scope of work in the DoD-funded award will require HRPO review of the entire protocol (DoD and non-DoD funded). DoD human subjects protection requirements may be applied to non-DoD funded work and necessitate extensive revisions to the protocol. Applications that involve recruitment of human subjects must indicate the quarterly enrollment targets across all sites in [Attachment 5: Statement of Work \(SOW\)](#). Successful applicants will work with USAMRAA to establish milestones for human subjects recruitment. Continued support for the project will be based upon satisfactory progress in meeting the established milestones. Refer to the General Application Instructions, Appendix 1, and the Human Subject Resource Document available on the electronic Biomedical Research Application Portal (eBRAP) “Funding Opportunities & Forms” web page (<https://ebrap.org/eBRAP/public/Program.htm>) for additional information.

**Research Involving Animals:** All DoD-funded research involving new and ongoing research with animals must be reviewed and approved by the USAMRMC ORP Animal Care and Use Review Office (ACURO), in addition to the local Institutional Animal Care and Use Committee (IACUC) of record. IACUC approval at the time of submission is *not* required. Specific documents relating to the use of animals in the proposed research will be requested **if the application is selected for funding**. The ACURO must review and approve all animal use prior to the start of working with animals, including amendments to ongoing projects. PIs must submit the institutional animal use protocol, IACUC approval of that protocol, and a version of the animal use appendix titled, “Research Involving Animals.” ***Allow at least 2 to 3 months for ACURO regulatory review and approval processes for animal studies.*** Refer to the General Application Instructions, Appendix 1, for additional information.

The CDMRP intends that information, data, and research resources generated under awards funded by this Program Announcement be made available to the research community (which includes both scientific and consumer advocacy communities) and to the public at large. For additional guidance, refer to the General Application Instructions, Appendix 2, Section K.

## **II.C. Eligibility Information**

### **II.C.1. Eligible Applicants**

**II.C.1.a. Organization:** All organizations, including international organizations, are eligible to apply.

**Government Agencies Within the United States:** Local, state, and Federal Government agencies are eligible to the extent that applications do not overlap with their fully funded internal

programs. Such agencies are required to explain how their applications do not overlap with their internal programs.

As applications for this Program Announcement may be submitted by extramural and intramural organizations, these terms are defined below.

**Extramural Organization:** An eligible non-DoD organization. Examples of extramural organizations include academic institutions, biotechnology companies, foundations, other Federal Government organization other than the DoD, and research institutes.

**Intramural DoD Organization:** A DoD laboratory, DoD military treatment facility, and/or DoD activity embedded within a civilian medical center.

**Note:** Applications from an intramural DoD organization or from an extramural Federal Government organization may be submitted to Grants.gov through a research foundation.

The USAMRAA makes awards to eligible organizations, not to individuals.

### **II.C.1.b. Principal Investigator**

Academy Dean and Assistant Dean:

- Must be an independent, established ovarian cancer researcher.
- Must have ovarian cancer research funding (past and present).
- Must have a record of ovarian cancer publications in peer-reviewed journals.

An eligible PI, regardless of ethnicity, nationality, or citizenship status, must be employed by, or affiliated with, an eligible organization.

The CDMRP encourages all PIs to participate in a digital identifier initiative through Open Researcher and Contributor ID, Inc. (ORCID). Registration for a unique ORCID identifier can be done online at <https://orcid.org/>.

### **II.C.2. Cost Sharing**

Cost sharing/matching is not an eligibility requirement.

### **II.C.3. Other**

Organizations must be able to access **.gov** and **.mil** websites in order to fulfill the financial and technical deliverable requirements of the award and submit invoices for payment.

For general information on required qualifications for award recipients, refer to the General Application Instructions, Appendix 3.

Refer to [Section II.H.2, Administrative Actions](#), for a list of administrative actions that may be taken if a pre-application or application does not meet the administrative, eligibility, or ethical requirements defined in this Program Announcement.

## **II.D. Application and Submission Information**

*Submission of applications that are essentially identical or propose essentially the same research project to different funding opportunities within the same program and fiscal year is prohibited and will result in administrative withdrawal of the duplicative application(s).*

**Extramural Submission:** An application submitted by an organization to Grants.gov.

**Intramural DoD Submission:** An application submitted by a DoD organization to eBRAP.

### **II.D.1. Address to Request Application Package**

eBRAP is a multifunctional web-based system that allows PIs to submit their pre-applications electronically through a secure connection, to view and edit the content of their pre-applications and full applications, to receive communications from the CDMRP, and to submit documentation during award negotiations and period of performance.

**Extramural Submissions:**

- Pre-application content and forms must be accessed and submitted at [eBRAP.org](https://eBRAP.org).
- Full application packages must be accessed and submitted at Grants.gov.

**Intramural DoD Submissions:**

- Pre-application content and forms must be accessed and submitted at [eBRAP.org](https://eBRAP.org).
- Full application packages must be accessed and submitted at [eBRAP.org](https://eBRAP.org).

### **II.D.2. Content and Form of the Application Submission**

Submission is a two-step process requiring both *pre-application* and *full application* as indicated below. The submission process should be started early to avoid missing deadlines. There are no grace periods.

**Pre-Application Submission:** All pre-applications for both extramural and intramural organizations must be submitted through eBRAP (<https://eBRAP.org/>).

**Full Application Submission:** Full applications must be submitted through the online portals as described below.

***Extramural Organization Submissions:*** Full applications from extramural organizations must be submitted through Grants.gov Workspace. Applications submitted by extramural organizations (e.g., research foundations) on behalf of intramural DoD or other Federal organizations or investigators will be considered extramural submissions. Applications from extramural organizations, including non-DoD Federal organizations, received through eBRAP will be withdrawn. See definitions in [Section II.C.1, Eligible Applicants](#).

***Intramural DoD Organization Submissions:*** Intramural DoD organizations may submit full applications to either eBRAP or Grants.gov. Intramural DoD organizations that are unable to submit to Grants.gov should submit through eBRAP. Intramural DoD organizations with the capability to submit through Grants.gov may submit following the instructions for extramural submissions through Grants.gov or may submit to eBRAP.

***For Both Extramural and Intramural Applicants:*** eBRAP allows an organization's representatives and PIs to view and modify the full application submissions associated with them. eBRAP will validate full application files against the specific Program Announcement requirements, and discrepancies will be noted in an email to the PI and in the "Full Application Files" tab in eBRAP. It is the applicant's responsibility to review all application components for accuracy as well as ensure proper ordering as specified in this Program Announcement.

***The application title, eBRAP log number, and all information for the PI, Business Official(s), performing organization, and contracting organization must be consistent throughout the entire pre-application and full application submission process.*** Inconsistencies may delay application processing and limit or negate the ability to view, modify, and verify the application in eBRAP. If any changes need to be made, the applicant should contact the CDMRP Help Desk at [help@eBRAP.org](mailto:help@eBRAP.org) or 301-682-5507 prior to the application submission deadline.

The Ovarian Cancer Academy Dean and Assistant Dean (Leadership) Award mechanism is structured to accommodate two PIs. The Academy Dean will be identified as the Initiating PI and will be responsible for the majority of the administrative tasks associated with application submission. The Assistant Dean will be identified as a Partnering PI. The Initiating PI must complete the pre-application submission process and submit the contact information for the Partnering PI. The Partnering PI will then be notified of the pre-application submission separately by email. ***The Partnering PI must follow the link in the notification email in order to associate his/her full application package with that of the Initiating PI. After following the link, the Partnering PI must verify his/her contact information, organization, and designation as an extramural or intramural submission within eBRAP.*** If not previously registered, the Partnering PI must register in eBRAP. A new pre-application based on this research project should not be initiated by the Partnering PI. Do not delay completing these steps. If they are not completed, the Partnering PI will not be able to view and modify his/her application during the verification period in eBRAP. If these steps are not completed, intramural partners will not be able to submit the Partnering PI required full application package components to eBRAP.

#### **II.D.2.a. Step 1: Pre-Application Submission Content**

***During the pre-application process, eBRAP assigns each submission a unique log number. This unique eBRAP log number is required during the full application submission process.***

To begin the pre-application process, first select whether the submitting organization is extramural or intramural, then confirm your selection or cancel. **Incorrect selection of extramural or intramural submission type will delay processing.**

If an error has been made in the selection of extramural versus intramural and the pre-application submission deadline has passed, the PI or Business Official must contact the CDMRP Help Desk at [help@eBRAP.org](mailto:help@eBRAP.org) or 301-682-5507 to request a change in designation.

All pre-application components must be submitted by the Initiating PI through eBRAP (<https://eBRAP.org/>). Because the invitation to submit an application is based on the contents of the pre-application, investigators should not change the title or research objectives after the pre-application is submitted.

The applicant organization and associated PIs identified in the pre-application should be the same as those intended for the subsequent application submission. If any changes are necessary after submission of the pre-application, the PI must contact the CDMRP Help Desk at [help@eBRAP.org](mailto:help@eBRAP.org) or 301-682-5507.

A change in PI or organization after submission of the pre-application may be allowed after review of a submitted written appeal (contact the CDMRP Help Desk at [help@eBRAP.org](mailto:help@eBRAP.org) or 301-682-5507) and at the discretion of the USAMRAA Grants Officer.

PIs with an ORCID identifier should enter that information in the appropriate field in the “My Profile” tab in the “Account Information” section of eBRAP.

The pre-application consists of the following components, which are organized in eBRAP by separate tabs (refer to the General Application Instructions, Section II.B, for additional information on pre-application submission):

- **Tab 1 – Application Information**

Submission of application information includes assignment of primary and secondary research classification codes, which may be found at <https://ebrap.org/eBRAP/public/Program.htm>. Note that the codes have recently been revised. Applicants are strongly encouraged to review and confirm the codes prior to making their selection.

- **Tab 2 – Application Contacts**

Enter contact information for the PI. Enter the organization’s Business Official responsible for sponsored program administration (the “person to be contacted on matters involving this application” in Block 5 of the Grants.gov SF424 Research & Related Form). The Business Official must be either selected from the eBRAP list or invited in order for the pre-application to be submitted.

Select the performing organization (site at which the PI will perform the proposed work) and the contracting organization (organization submitting on behalf of the PI, which corresponds to Block 5 on the Grants.gov SF424 Research & Related Form), and click on “Add

Organizations to this Pre-application.” The organization(s) must be either selected from the eBRAP drop-down list or invited in order for the pre-application to be submitted.

It is recommended that PIs identify an Alternate Submitter in the event that assistance with pre-application submission is needed.

- **Tab 3 – Collaborators and Key Personnel**

Enter the name, organization, and role of all collaborators and key personnel associated with the application.

[FY19 OCRP Programmatic Panel members](#) should not be involved in any pre-application or application. For questions related to panel members and pre-applications or applications, refer to [Section II.H.2.c, Withdrawal](#), or contact the CDMRP Help Desk at [help@eBRAP.org](mailto:help@eBRAP.org) or 301-682-5507.

The Initiating PI must enter the contact information for the Partnering PI in the Partnering PI section.

- **Tab 4 – Conflicts of Interest (COIs)**

List all individuals other than collaborators and key personnel who may have a COI in the review of the application (including those with whom the PI has a personal or professional relationship).

- **Tab 5 – Pre-Application Files**

*Note: Upload documents as individual PDF files unless otherwise noted. eBRAP will not allow a file to be uploaded if the number of pages exceeds the limit specified below.*

- **Preproposal Narrative (five-page limit):** The Preproposal Narrative page limit applies to text and non-text elements (e.g., figures, tables, graphs, photographs, diagrams, chemical structures, drawings) used to describe the project. Inclusion of URLs that provide additional information to expand the Preproposal Narrative and could confer an unfair competitive advantage is prohibited and may result in administrative withdrawal of the pre-application.

The Preproposal Narrative should include the following:

- **Background and Experience:** Describe the background of the Academy Dean and Assistant Dean and their experiences as established ovarian cancer researchers.
- **Vision:** Describe the Academy Leadership’s vision of the OCA and how it will continue to serve as a non-traditional, non-conventional, virtual training platform, including intensive mentoring and networking for the ECIs.

- **Management of the Academy:** Describe the different roles envisioned for the Academy Dean and the Assistant Dean and how they will synergistically facilitate the professional development of the ECIs into leading ovarian cancer researchers.
- **Research:** Briefly describe the proposed ovarian cancer pilot research projects that will be supported by this award.
- **Pre-Application Supporting Documentation:** The items to be included as supporting documentation for the pre-application *must be uploaded as individual files* and are limited to the following:
  - References Cited (one-page limit): List the references cited (including URLs if available) in the Preproposal Narrative using a standard reference format that includes the full citation (i.e., author[s], year published, reference title, and reference source, including volume, chapter, page numbers, and publisher, as appropriate).
  - List of Abbreviations, Acronyms, and Symbols: Provide a list of abbreviations, acronyms, and symbols used in the Preproposal Narrative.
  - Key Personnel Biographical Sketches (five-page limit per individual): *All biographical sketches should be uploaded as a single combined file.* Biographical sketches should be used to demonstrate background and expertise through education, positions, publications, and previous work accomplished.

- **Tab 6 – Submit Pre-Application**

This tab must be completed for the pre-application to be accepted and processed.

### **Pre-Application Screening**

- **Pre-Application Screening Criteria**

To determine the technical merits of the pre-application and the relevance to the mission of the DHP and the OCRP, pre-applications will be screened based on the following criteria:

- **Background and Experience:** To what extent the Academy Dean and Assistant Dean are established ovarian cancer researchers.
- **Vision:** To what degree the proposed vision for the Academy will maintain it as a non-traditional, non-conventional training platform, including intensive mentoring and networking in a virtual environment for the ECIs.
- **Management of the Academy:** To what extent the Academy Dean and Assistant Dean have separate roles in managing the Academy. To what extent the distinct leadership roles synergistically facilitate the professional development of the ECIs into leading ovarian cancer researchers.

- **Research:** To what extent the proposed pilot research projects will improve the Academy and/or impact ovarian cancer or patient/survivor care.

- **Notification of Pre-Application Screening Results**

Following the pre-application screening, the Initiating PI will be notified as to whether or not they are invited to submit applications; however, they will not receive feedback (e.g., a critique of strengths and weaknesses) on their pre-application. The estimated timeframe for notification of invitation to submit an application is indicated in [Section I, Overview of the Funding Opportunity](#). Invitations to submit a full application are based on the Pre-Application Screening Criteria listed above.

### **II.D.2.b. Step 2: Full Application Submission Content**

Applications will not be accepted unless notification of invitation has been received by the Initiating PI.

*The CDMRP cannot make allowances/exceptions to its policies for submission problems encountered by the applicant organization using system-to-system interfaces with Grants.gov.*

Each application submission must include the completed full application package for this Program Announcement. The full application package is submitted by the Authorized Organizational Representative through Grants.gov (<https://www.grants.gov/>) for extramural organizations or through eBRAP (<https://ebrap.org/>) for intramural organizations. See Table 1 below for more specific guidelines. For the Ovarian Cancer Academy Dean and Assistant Dean (Leadership) Award, additional application components are also required and should be submitted as directed in the [Additional Application Components](#) section.

#### **II.D.2.b.i. Full Application Guidelines**

Extramural organizations must submit full applications through Grants.gov. Applicants must create a Grants.gov Workspace for submission, which allows the application components to be completed online and routed through the applicant organization for review prior to submission. Describe the roadmap as to how the Academy will develop highly productive ovarian cancer researchers who will be recognized as leading researchers through a collaborative and interactive research training environment within the 5-year period of performance.
- **Background and Experience:** Describe the Academy Leadership’s background and experience as established ovarian cancer researchers. Describe the record of mentoring and training junior investigators and how this mentorship contributed significantly to the junior investigators’ careers. Explain how the complementary experience of both candidates contributes to the ideal leadership of the Academy.
- **Management of the Academy:** Clearly define the roles that will be filled by the Academy Dean and Assistant Dean in leading the OCA. - **Intramural DoD Collaborator(s):** Complete the DoD Military Budget Form and upload to Grants.gov attachment form as Attachment 8. (Refer to the General Application Instructions, Section III.A.8, for detailed information.)

In addition to the complete application package, Ovarian Cancer Academy Dean and Assistant Dean (Leadership) Award applications also require the following components:

- **Oral Presentation**

Candidates for Academy Dean and Assistant Dean selected for Stage 2 Programmatic Review will be required to give an oral presentation (see [Section II.E.1.b, Programmatic Review](#)) in the Baltimore/Washington, DC area in 2019. In the event a PI is invited to the Programmatic Review, Stage 2 (see [Section II.E.1.b, Programmatic Review](#)), but is unable to attend, CDMRP Staff and the Grants Officer will consider alternative arrangements on a case-by-case basis.

Each presentation will include a 45-minute talk by the candidates (Academy Dean/Assistant Dean pairs), followed by a 20-minute question and answer session with OCRP Programmatic Panel members. The following questions will be the topics for discussion during the PIs' talk and the question and answer session. PIs who are selected should prepare a presentation consisting of no more than 10 slides that specifically address:

- What conceptual or intellectual barriers do you consider as important to overcome in the career development and sustainment of investigators dedicated to ovarian cancer research?
- How do you envision leading the Academy as it continues its non-traditional, non-conventional training of the ECIs in a virtual environment?
- How will you use your leadership skills to encourage partnerships, collaborations, resource sharing, and career growth for the ECIs to include the proposed collaborative pilot studies? How will you encourage sustained involvement of the Academy Alumni in the Academy?

- What do you envision as the agenda for and outcomes from the first 1-day Academy annual workshop in which you will lead?
- What are the proposed milestones and outcomes for the ECIs during the 5 years in the Academy?
- Briefly introduce your proposed ovarian cancer pilot research projects that will be conducted as collaborative efforts with the ECIs.

### **II.D.3. Dun and Bradstreet Data Universal Numbering System (DUNS) Number and System for Award Management (SAM)**

Applicant organizations and all sub-recipient organizations must have a DUNS number to submit applications to Grants.gov. Following retrieval and processing of the full application, eBRAP will notify the organizational representatives and PI by email to log into eBRAP to review, modify, and verify the full application submission. eBRAP will validate retrieved files against the specific Program Announcement requirements, and discrepancies will be noted in both the email and in the “Full Application Files” tab in eBRAP. eBRAP does not confirm the accuracy of file content. It is the applicant’s responsibility to review all application components and ensure proper ordering as specified in the Program Announcement. ***If either the Project Narrative or the budget fails eBRAP validation or needs to be modified, an updated full application package must be submitted prior to the application submission deadline.*** The Project Narrative and Budget Form cannot be changed after the application submission deadline.

***Extramural Submission:*** The full application package submitted to Grants.gov may be viewed and modified in eBRAP until the end of the application verification period. During the application verification period, the full application package, ***with the exception of the Project Narrative and Budget Form,*** may be modified.

***Intramural DoD Submission:*** After eBRAP has processed the full application, the organizational Resource Manager/Comptroller/Task Area Manager or equivalent Business Official and PI will receive email notification of the status and will be able to view and modify application components in eBRAP. During the application verification period, the full application package, ***with the exception of the Project Narrative and Budget Form***, may be modified. The Resource Manager/Comptroller/Task Area Manager or equivalent Business Official should log into eBRAP to review and to approve the application package prior to the application verification deadline.

***For All Submissions:*** Verify that subaward budget(s) with budget justification are present in eBRAP during the application verification period. If these components are missing, upload them to eBRAP before the end of the application verification period.

#### **II.D.5. Funding Restrictions**

The maximum period of performance is **5** years.

The anticipated combined direct costs budgeted for the entire period of performance for the Initiating PI's and the Partnering PI's applications will not exceed **\$1.75M**. If indirect cost rates have been negotiated, indirect costs are to be budgeted in accordance with the organization's negotiated rate. Collaborating organizations should budget associated indirect costs in accordance with each organization's negotiated rate. The combined budgeted direct costs approved by the Government will not exceed **\$1.75M** or use an indirect cost rate exceeding each organization's negotiated rate.

A separate award will be made to each PI's organization.

The PIs are expected to be partners in the project, and direct cost funding should be divided accordingly, unless otherwise warranted and clearly justified.

All direct and indirect costs of any subaward or contract must be included in the total direct costs of the primary award.

For this award mechanism, direct costs must be requested for:

- Costs associated with planning and holding the annual 1-day workshop with Academy members, including costs associated with external speakers
- Costs associated with planning and holding the biennial multi-day workshop in coordination with the OCRP Program staff, including costs associated with external speakers

These travel costs are in addition to those allowed for annual scientific/technical meetings.

- Costs associated with sustaining Academy Alumni involvement in the Academy (e.g., funding travel for participation in the annual workshops and in the Academy advisory board).
- Administrative costs (e.g., salary for Administrative Assistant[s]).

May be requested for (not all-inclusive):

- Salary
- Research supplies and salaries for Academy collaborative research projects
- Costs associated with establishing and maintaining a “virtual” academy (e.g., hardware and/or software for audio- or video-teleconferencing or web-based communications)
- Support for multidisciplinary collaborations, including travel
- Travel between institutions participating in the Academy
- Travel to 1-day and biennial multi-day workshops
- Travel costs of up to \$1,800 per Academy Leader to travel to scientific/technical meetings per year in addition to the required meetings described above. The intent of travel costs to scientific/technical meetings is to present project outcomes or disseminate project results.

Must not be requested for:

- Tuition for graduate students

Awards made to extramural organizations will consist solely of assistance agreements (grants and cooperative agreements). For extramural awards with an intragovernmental component, direct transfer of funds from an extramural award recipient to a DoD or other Federal agency is not allowed except under very limited circumstances. Funding to intramural DoD and other Federal agencies will be managed through a direct funds transfer. Intramural applicants are responsible for coordinating through their agency’s procedures the use of contractual or assistance funding awards or other appropriate agreements to support extramural collaborators. Application packages from associated extramural partners will be funded through assistance agreements.

The time is considered when establishing the award’s period of performance. It is anticipated that awards made from this FY19 funding opportunity will be funded with FY19 and FY23 funds, which will expire for use on September 30, 2025 and 2029, respectively.

  - To what extent the Academy Dean's and Assistant Dean's background and experience in ovarian cancer demonstrate their potential for leadership of the OCA.
  - To what extent the Academy Leadership's record of mentoring and training junior investigators in ovarian cancer research indicates the potential for successful mentorship and career development of the ECIs from multiple institutions and disciplines, at different stages within the Academy.
  - To what extent the Academy Leadership is committed to leading the OCA and ensuring that it provides collaborative mentoring of ECIs with the goal of developing sustainable, independent careers as leaders in ovarian cancer research at their institutions and in their field.
- **Vision**
  - To what extent the vision of the Academy Leadership for the continuation of the OCA meets the intent of this award mechanism to continue this unique, interactive virtual Academy that will provide intensive mentoring, networking, and a collaborative peer group for the development and sustainment of ECIs.
  - To what degree the Academy roadmap will develop successful leaders in ovarian cancer research in a collaborative research training environment within the 5-year period of performance.
- **Management of the Academy**
  - To what degree the application has clearly defined synergistic roles for the Academy Dean and Assistant Dean leadership.
  - To what extent the application articulated a plan to facilitate communication and collaboration among all of the ECIs and Designated Mentors, as well as the ovarian cancer research and advocacy communities.
  - To what extent the OCA will provide a synergistic approach to the development of junior faculty and prepare each of the ECIs for an independent and sustainable career in ovarian cancer research.

- How well the Academy Leadership will assist the ECIs in overcoming the barriers in initiating and sustaining a career in ovarian cancer research.
- To what extent the application has outlined criteria that will be used to evaluate the research progress made by all of the ECIs, as well as their career progression and sustainment as independent investigators in ovarian cancer research.
- How well the measurable outcomes to be achieved by the ECIs by the end of the 5-year period of performance have been described and will contribute to the professional development of the Academy members.
- **Impact**
  - To what degree the continued OCA will provide intensive mentoring, networking, and a peer group for the ECIs in a unique, interactive, collaborative virtual research training environment that will allow them to develop and sustain careers, becoming leading ovarian cancer researchers.
- **Research Strategy and Feasibility**
  - To what extent the scientific rationale supports the hypothesis and feasibility of this pilot project, as demonstrated by a review and analysis of the literature.

In addition, the following **unscored** criteria will also contribute to the overall evaluation of the application:

- **Budget**
  - Whether the **direct** maximum costs are equal to or less than the allowable direct maximum costs as published in the Program Announcement.
  - Whether the budget is appropriate for the proposed research.
- **Application Presentation**
  - To what extent the writing, clarity, and presentation of the application components influence the review.
- **Environment**
  - If applicable, to what degree the intellectual and material property plan is appropriate.

#### **II.E.1.b. Programmatic Review**

To make funding recommendations and select the application(s) that, individually or collectively, will best achieve the program objectives, the following criteria are used by programmatic reviewers:

- Ratings and evaluations of the peer reviewers
- Relevance to the mission of the DHP and FY19 OCRP, as evidenced by the following:
  - **Stage 1:** During the first stage of programmatic review, applications will be selected for the second stage using the following criteria:
    - Ratings and evaluations of the peer reviewers
    - Relative impact
    - Programmatic relevance
    - Adherence to the intent of the award mechanism
  - **Stage 2:** During the second stage of programmatic review, the following criteria will be used:
    - Understanding of the barriers important in initiating and sustaining a career in ovarian cancer research
    - Articulating a vision for the Academy as a non-traditional, non-conventional training platform in a virtual environment
    - Leadership skills to encourage partnerships, collaborations, resource sharing, and career growth for the ECIs to include the proposed collaborative pilot studies
    - Articulating commitment and passion to the successful professional development of the ECIs of the DoD OCA
    - Capabilities to lead the Academy such that the ECIs develop partnerships, collaborations, and career growth to ensure their dedication, commitment, and productivity as leading researchers in ovarian cancer

## **II.E.2. Application Review and Selection Process**

All applications are evaluated by scientists, clinicians, and consumers in a two-tier review process. The first tier is **peer review**, the evaluation of applications against established criteria to determine technical merit, where each application is assessed for its own merit, independent of other applications. The second tier is **programmatic review**, a comparison-based process in which applications with high scientific and technical merit are further evaluated for programmatic relevance. Final recommendations for funding are made to the Commanding General, USAMRMC, on behalf of the DHA and the OASD(HA). ***The highest-scoring applications from the first tier of review are not automatically recommended for funding. Funding recommendations depend on various factors as described in [Section II.E.1.b, Programmatic Review](#).*** Additional information about the two-tier process used by the CDMRP can be found at <https://cdmrp.army.mil/about/2tierRevProcess>. A PI Information Paper

describing the funding recommendations and review process for the award mechanisms for the OCRP will be provided to the PI and posted on the CDMRP website.

All CDMRP review processes are conducted confidentially to maintain the integrity of the merit-based selection process. Panel members sign a statement declaring that application and evaluation information will not be disclosed outside the panel. Violations of confidentiality can result in the dissolving of a panel(s) and other corrective actions. In addition, personnel at the applicant or collaborating organizations are prohibited from contacting persons involved in the review and approval process to gain protected evaluation information or to influence the evaluation process. Violations of these prohibitions will result in the administrative withdrawal of the organization's application. Violations by panel members or applicants that compromise the confidentiality of the review and approval process may also result in suspension or debarment from Federal awards. Furthermore, the unauthorized disclosure of confidential information of one party to another third party is a crime in accordance with 18 USC 1905.

### **II.E.3. Integrity and Performance Information**

Prior to making an assistance agreement award where the Federal share is expected to exceed the simplified acquisition threshold, as defined in 2 CFR 200.88, over the period of performance, the Federal awarding agency is required to review and consider any information about the applicant that is available in the Federal Awardee Performance and Integrity Information System (FAPIIS).
